4.1 Modification 6 Update

Chris Higgins provided an update on Modification 6 to our current Project Approval. Key slides from the presentation below. The full presentation is at the end of these minutes.

Current approvals underway 

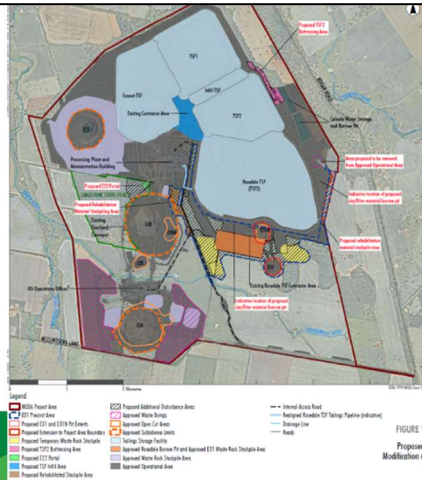
1. Modification (Mod 6) to our current approvals to cater for design changes to what we are already approved
2. New State Significant Development for the E44 ore body and the Rocklands TSF

- Modifications are required when a relatively small change to the approved activities is planned
- Two modifications (6 & 7) were previously planned for 2021, however they have been combined into one Modification, #6
- Mod 6 scoping report submitted in October
- Mod 6 assessment submission 18th November

Mod 6 - Inclusions

- Two modifications were planned for 2021, however they have been combined into one Modification, #6
- Modification 6 will compose of:
 - Changes to two E31 open cut disturbance
 - E22 block cave portal to surface
 - TSF2 east embankment buttress
 - Borrow pits for TSF construction
 - Realignment of pipelines
 - Altered alignment for Infill TSF Extension embankment
 - New rehabilitation stockpile area

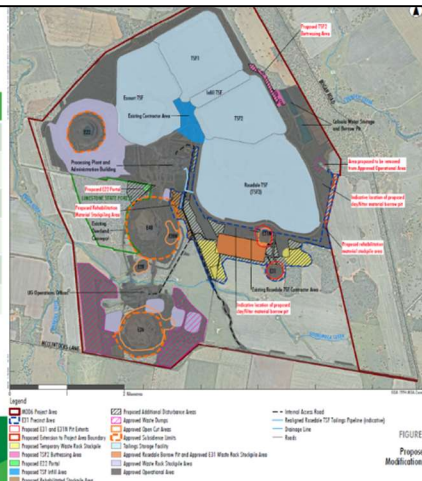

A: Chris Higgins – Mod 6 will be submitted on the 18 November.

E44 Update

Stacey Kelly provided an update on the E44 open pit and potential future mine developments including MJH and E22. The feasibility Study for E44 will be completed in 2022.

E31 Open Pits Update

Pre stripping will commence the second half of 2022 for commencement in 2023.

No further questions on Northparkes Production or Modification 6 update.

4.2 Environment and Farming Update

Chris Higgins provided an update on the environment and farm performance, with the key points of discussion being:

- No reportable environmental incidents or complaints in 2021
- Tailings dust from TSF1 and Estcourt TSF has been an issue in 2021, however recent ripping has provided an effective control. Northparkes approval is being worked through to use the tractor within the Mining Lease to enable a rapid response to dust risks.

- Vibration has been noted at neighbours' residences in 2021. Quotes for property inspections and vibration monitors are being sought.
- After many years of work, the Kokoda Offset revegetation works have been completed.

6. GENERAL BUSINESS

Q: Bill Jayet – Asked how the levels of staffing currently are at Northparkes and if COVID and the 7:7 roster has changed anything?

A: Stacey Kelly – Provided an update to the group around recruiting some recently highly skilled positions over the last few months, we continue to attract people and the availability of housing has improved.
